Gross Estate + Lifetime Taxable Gifts > Exclusion

2020 \$11.58 million2021 \$11.7 million

2022 \$12.06 million

2023 \$12.92 million

GROSS ESTATE

- Assets owned by Decedent on date of death
- Assets not owned by decedent at death

DEADLINES

"Mandatory" Estate Tax Return

Filing 706 and payment of estate tax

•9 months from date of death

Six-month filing extension

- 15 months (9 + 6 = 15) from date of death
- Does NOT extend deadline to pay estate tax!

DEADLINES

"Optional" Estate Tax Return

Five years from date of death

"Optional" returns filed solely to elect Portability of Deceased Spousal Unused Exclusion Amount
