

Issues Out of CREZ

Pursuant to legislation enacted in 2005, the Public Utility Commission identified five areas in Texas where large wind generators committed to construct wind farms, and designated them as Competitive Renewable Energy Zones (CREZ). It then identified more than 100 transmission line projects needed to support the CREZ, and designated eight transmission service providers to implement those projects at an estimated cost of \$5 billion (ultimately to be paid by electric consumers). The exact routes for these transmission lines, primarily through private property, were determined through 30 contested case proceedings conducted by SOAH, many with dozens and some with hundreds of landowners, as well as other state agencies intervening as parties. This session focuses on the variety of procedural and substantive issues that arose from this complex administrative litigation.


