**John C. Akard Lecture Delivered by Melissa B. Jacoby**

Melissa B. Jacoby is the Graham Kenan Professor of Law at the University of North Carolina at Chapel Hill, where she teaches bankruptcy law, contract law, and commercial law, including and especially secured transactions. Professor Jacoby's Akard Lecture is entitled *Bankruptcy as a Public-Private Partnership*.

Jacoby is an elected member to the American Law Institute, the National Bankruptcy Conference, the American College of Bankruptcy, and the American College of Commercial Finance Lawyers, and has served as the Robert M. Zinman Scholar for the American Bankruptcy Institute. She is a recipient of the Grant Gilmore Award for scholarship from the American College of Commercial Finance Lawyers and the Byrd Award for teaching, among other honors. Her recent scholarly articles include *Tracing Equity: Realizing and Allocating Value in Chapter 11* (with Ted Janger), published in the Texas Law Review, and *Corporate Bankruptcy Hybridity*, forthcoming in the University of Pennsylvania Law Review, which will be highlighted in her Akard Lecture.

Early in her career, Jacoby was a law clerk for the Honorable Robert E. Ginsberg of the United States Bankruptcy Court for the Northern District of Illinois and the Honorable Marjorie O. Rendell of the United States Court of Appeals for the Third Circuit. Jacoby graduated from the University of Pennsylvania Law School, as well as from Penn's College of Arts and Sciences, majoring in history.
