#### HON. BARRY RUSSELL

Chief Judge Emeritus, U.S. Bankruptcy Court Judge, Central District of California

The Honorable Barry Russell was appointed to the Court in 1974 by the Judges of the District Court and was reappointed in 1986 and 2000 by the United States Court of Appeals for the Ninth Circuit.

In 1988 he became the first American invited by the Supreme People's Court, People's Republic of China to lecture on bankruptcy law. Judge Russell has authored the Bankruptcy Evidence Manual, West Publishing Co., since 1987 with a new edition published annually.

Judge Russell is currently a Faculty Member of the Federal Judicial Center, Washington, D.C., a position he has held since 1977.


