#### Sun Tzu—On the Art of Patent Prosecution

Sun Tzu said: "If you know the enemy and know yourself, you need not fear the result of a hundred battles. If you know yourself but not the enemy, for every victory gained you will also suffer a defeat. If you know neither the enemy nor yourself, you will succumb in every battle."

Patent Prosecution is not war, but sometimes it certainly feels like it. Patent practitioners are all generally confident in their own abilities and highly knowledgeable about their client's inventions, but what do they know about the Examiner Corps? What level is your Examiner, and how much authority does that Examiner have? Why is the Examiner more receptive to negotiation some days than others?
