Integrating and Managing Wind Generation: The European and ERCOT Experiences

One of the major challenges to integrating additional wind generation to the overall mix of supply is managing abrupt changes in the available power flowing from wind farms to the grid. The Europeans, in particular Spain and Germany, have taken a leadership role in managing wind integration, and have pushed their use of wind power to levels that far exceed what is being done in the U.S. generally, and even in ERCOT. This session includes a special presentation from RED ELÉCTRICA de España, the Spanish grid operator, on their approach to wind integration (with opportunities for Q&A); updates from ERCOT on this issue; and discussion of how the Spanish experience might inform the integration of higher levels of wind power in Texas.


