- The design is based on COSO framework:
 - -Control environment
 - Risk assessment
 - Control activities
 - Information and communication
 - -Monitoring

Internal Controls: Why have them?

- Internal controls are the process, affected by the organization's board, management, audit committee (if one is in place), and other entity personnel, and designed to provide reasonable assurance about the organization's:
 - Financial reporting reliability
 - Compliance with applicable laws and regulations
 - Effectiveness and efficiency of operations
- Internal controls cannot:
 - guarantee reliability of financial reporting
 - guarantee compliance with laws and regulations
 - guarantee an organization's success or survival
