Appointments Clause

 The President "by and with the advice and consent of the Senate, shall appoint . . . judges of the Supreme Court, and all other officers of the United States, whose appointments are not herein otherwise provided for, and which shall be established by law: but the Congress may by law vest the appointment of such inferior officers, as they think proper, in the President alone, in the courts of law, or in the <u>heads of</u> <u>departments</u>."

Background

- "Buckets-of-Money" investment strategy.
- Enforcement penalty challenge based on ALJs being unconstitutional: "US officer" vs. "inferior officer." Also claims of ALJ "bias."
- D.C. Circuit disagrees (10th Circuit had earlier agreed); Supreme Court takes the case.
- U.S. Solicitor General defends SEC at D.C. Circuit; does a 180° change at Supreme Court and attacks the SEC's decision.

Supreme Court Consideration

- Supreme Court appoints an amicus curiae to defend the SEC decision.
- Other amici file briefs, such as law professors, ALJ organizations, wealthy investors.
- Lively oral argument, active questioning: independent, meritbased, civil-service system vs. political accountability? new "US officer" definition based on who makes final decision?
