### B. The Stark Statute

Commonly known as the Stark Statute, The Ethics in Patient Referrals Act, Section 1877 of the Social Security Act (42 U.S.C. §1395nn), restricts referrals by physicians to providers of certain "designated health services" ("DHS") under the Medicare and Medicaid programs and prohibits designated health services entity from submitting claims to Medicare for services resulting from prohibited referrals. The Stark regulations are located in Title 42 of the Code of Federal Regulations §411.350 - §411.389.

### 1. DHS

The following items or services are DHS:

- (a) Clinical laboratory services;
- (b) Physical therapy services;
- (c) Occupational therapy services;
- (d) Outpatient speech-language pathology services;
- (e) Radiology and certain other imaging services;
- (f) Durable medical equipment and supplies;
- (g) Parenternal and enteral nutrients, equipment, and supplies;
- (h) Prosthetics, orthotics, and prosthetic devices and supplies;
- (i) Home health services;
- (j) Outpatient prescription drugs; and
- (k) Inpatient and outpatient hospital services.

The Centers for Medicare and Medicaid Services maintain and annually update a List of Current Procedural Terminology (CPT)/Healthcare Common Procedure Coding System (HCPCS) Codes (Code List), which identifies all items and services included within certain DHS categories. The updated Code List is published in the Federal Register as an addendum to the annual Physician Fee Schedule final rule. The DHS categories defined by the Code List are: clinical laboratory services; physical therapy services, occupational therapy services, outpatient speech-language pathology services, radiology and certain other imaging services, and radiation therapy services and supplies. The following DHS categories are <u>defined at 42 C.F.R. §411.351 without</u> <u>reference to the Code List</u>: durable medical equipment and supplies; parenteral and enteral nutrients, equipment and supplies; prosthetics, orthotics, and prosthetic devices and
