#### STATISTICS TO DATE

- October Term 2018
  - 67 merits decisions in argued cases
  - Decisions divided 5-3 or 5-4: 21 (29%)
  - Unanimous: 27 cases (38%)
- Number of 5-4 opinions (historical)
  - 2017: 19 (26%)
  - 2016: 7 (10%)
  - 2015: 4 (5%)
  - 2014: 19 (26%)
  - 2013: 10 (14%)
  - 2012: 23 (29%)


- October Term 2019 (as of June 2)
  - 58 argued cases\*
  - 36 opinions issued in argued cases
  - Decisions divided 5-4 or 5-3: 5 (14%)
  - Unanimous: 16 (44%)
  - \* Some cases originally scheduled for March and April sittings were deferred to October 2020

### THE "SHADOW DOCKET"

- Summary dispositions, orders on applications for stay, other orders
- "[I]n less than three years, the Solicitor General has filed at least twenty-one applications for stays in the Supreme Court ... During the sixteen years of the George W. Bush and Obama Administrations, the Solicitor General filed a total of eight such applications." Stephen Vladeck, The Solicitor General and the Shadow Docket, 133 Harv. L. Rev. 124 (Nov. 2019)
- Notable orders granting stay applications
  - Republican Nat'l Committee v. Democratic Nat'l Committee (19A1016; Apr. 6)
    - Stayed order requiring Wisconsin to count absentee ballots postmarked after April 7, 2020
  - Wolf v. Innovation Law Lab (19A960; Mar. 11)
    - Stayed order enjoining "Remain in Mexico" policy for asylum seekers
  - Wolf v. Cook County (19A905; Feb. 21; 5-4); DHS v. NY (19A785; Jan. 27; 5-4)
    - · Stayed orders enjoining "Public Charge Rule" on nationwide basis and in Illinois
