### *What does “midstream” cover?*

- **Upstream:** Exploration and production
- **Midstream:** Transportation  
Storage  
Processing  
Marketing
- **Downstream:** Finished products  
Marketing and distribution

## *Oil vs. Gas*

- **Oil:** Produced at the wellhead and aggregated in storage tanks or central tank batteries
- **Gas:** Produced at the wellhead and aggregated via points of interconnection with a larger pipeline network

## *Gathering vs. Transportation*

- **Gathering:** The process of collecting gas from one or more wellheads and its relatively short movement downstream where it is aggregated for further movement
- **Transportation:** Movement of accumulated quantities of oil/gas to one or more downstream points
