

# ADDITIONAL INSURED COVERAGE

- · Manusc ript Polic y
  - <u>Insured</u>: Named Insured and "any...entity to whom the 'Insured' is <u>obliged by any oral or written 'Insured Contract'</u>...entered into be fore any relevant 'Occumence', to provide insurance such as is afforded by this Policy...."
  - Insured Contract: "any written or or al contract or agreement entered into by the 'Insured'... and pertaining to business under which the 'Insured' assumes the tort liability of another party to pay for 'Bodily Injury', 'Property Damage', 'Personal Injury' or 'Advertising Injury' to a 'Third Party' or organization. Tort Liability means a liability that would be imposed by law in the absence of any contract or agreement."
  - "[A]d ditional insureds are automatically added" "where required by written contract."
- · Contract
  - Indemnity allocations
  - Additional Insured: "[BP] shall be named as additional insureds in each of [Thansocean's] policies, except Workers' Compensation for liabilities assumed by [Thansocean] under the terms of this Contract."



# ADDITIONAL INSURED COVERAGE

## ATOFINA Contractor Policy & Contract Transocean Policy & Contract

### POLICY:

<u>Insured</u> is "[a] person or organization for whom you have agreed to provide insurance as is afforded by this policy."

### CONTRACT

"[ATO FINA] shall be named as additional insure d in e a c h o f C o ntra c to r's p o lic ie s, e xc e p t Workers' Compensation; however, such extension of coverage shall not apply with respect to any obligations for which [ATO FINA] has specifically agreed to indemnify Contractor."

### РО ЦС Ү:

Add itio na l Insure d coverage Transocean "is obliged by any oral or written 'Insured Contract'" or "where required by writte n contract, bid or work order"

"Insured Contract", whenever used in this Policy, shall mean any written or oral contract or agreement entered into by the "Insured"  $\dots$ and pertaining to business under which the "Insured" assumes the tort liability of another party. ... Tort Liability means a liability that would be imposed by law in the absence of any contractoragreement.

### CONTRACT:

"[BP] shall be named as additional insureds in each of [Transocean's] policies, except Workers' Compensation <u>for liabilities assumed</u> by [Transocean] under the terms of this Contract."
