I. INTRODUCTION

This is the fifteenth article in a series of annual reports on U.S. admiralty and maritime law and practice.¹ In these articles we try to call attention to the principal na-

tional-level developments that bear on the work of admiralty judges, lawyers, and scholars, and we look more closely at the relevant work of the U.S. Courts of Appeals for the Fifth and Eleventh Circuits. We do not warrant full coverage, although with respect to the Fifth and Eleventh Circuit Courts of Appeals, we try to be fairly thorough.²

II. MISCELLANEOUS DEVELOPMENTS AT THE NATIONAL LEVEL

A. Federal Rules Amendments

Amendments to the Federal Rules of Civil Procedure go into effect on December 1, 2015. These include changes to Rules 1, 4(m), 16(b), 26(b, c, d, f), 30(a, d), 31(a), 33(a), 34(b), 37(a, e), and 55(c). According to *U.S. Law Week*, “the most hotly contested changes are to Rule 37, governing e-discovery, and Rule 26, addressing overall proportionality of discovery.”³
