THE TCPA - PURPOSE

"The purpose of [the TCPA] is to encourage and safeguard the constitutional rights of persons to petition, speak freely, associate freely, and otherwise participate in government to the maximum extent permitted by law and, at the same time, protect the rights of a person to file meritorious lawsuits for demonstrable injury."

Tex. Civ. Prac. & Rem. Code § 27.002.

THE TCPA – BURDEN-SHIFTING FRAMEWORK

- Step One: Defendant must show by a preponderance of the evidence that the TCPA applies. § 27.005(b).
- Step Two: Plaintiff must show by **clear and specific evidence** a prima facie case for each essential element of the claim. § 27.005(c).
- "Evidence" includes pleadings. § 27.006(a).
