EVOLUTION OF A CONSPIRACY THEORY AN IDLE MIND IS THE DEVIL'S WORKSHOP?

- In moments of <u>powerlessness and uncertainty</u>, the brain kicks into analytical overdrive in an attempt to create a coherent and understandable narrative
- Real conspiracies (e.g., Watergate) support belief in other conspiracies
- Belief in one conspiracy is the strongest indicator for belief in other conspiracies
- "Backfire effect" efforts to debunk inaccurate information can leave people more convinced it is true

TYPES OF CONSPIRACY THEORIES DIFFERENT PERSPECTIVES



- Benevolent conspiracies, angelic forces behind scenes
- Enemy Outside, devilish figures scheming outside the community
- Enemy Within, lurking inside the nation, blend with public
- Enemy Below, lower class wanting to overturn social order
- Enemy Above, powerful people manipulating system for personal gain
