## A DECADE OF CHANGE AFFECTING PATENT PROTECTION AND ENFORCEMENT VALUE

1. Injunctive Relief Uncertain, even for a direct competitor
2. Patent damages are uncertain-recovery theories in flux
  - Willful infringement with trebling of recovery has higher standard than historical past
3. Procedural hurdles: venue narrowing and joinder restricted
4. Predictability of Validity is difficult, at best
  - America Invents Act (AIA) created a relatively fast, affordable way to challenge patents in litigation with results that historically have favored defendants
  - Attacks on validity in substantive areas include claim indefiniteness, novelty (obviousness) and patentable subject matter

## A DECADE OF CHANGE AFFECTING PATENT PROTECTION AND ENFORCEMENT VALUE

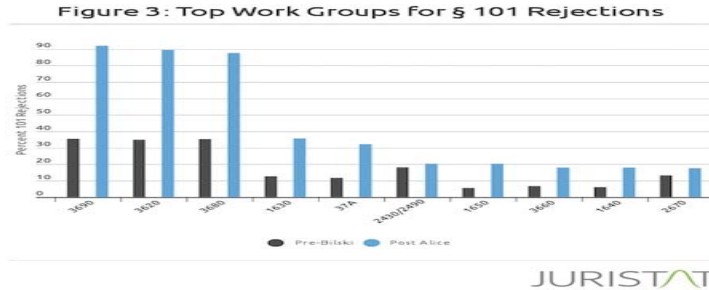
- *Alice Corp. v. CLS Bank* (134 S.Ct. 2347 (2014)) (No patent protection if patent claims are directed to an abstract idea, law of nature, or natural phenomena, and there is no other transforming 'inventive concept'. Claims must be directed to "significantly more" than an abstract idea.)
  - Since *Alice*, here are the overall 2014-2016 35 U.S.C. § 101 numbers compiled as of 12/22/2016 by Robert Sachs available at <http://www.bilskiblog.com>

## A DECADE OF CHANGE AFFECTING PATENT PROTECTION AND ENFORCEMENT VALUE

- Since *Alice*, § 101 rejection rates in some art units in the USPTO have jumped to around 90%. Top art units with rejections are: E-commerce, molecular biology, amusement/education devices, cryptography and security, microbiology, wave communications, immunology and printers/scanners.

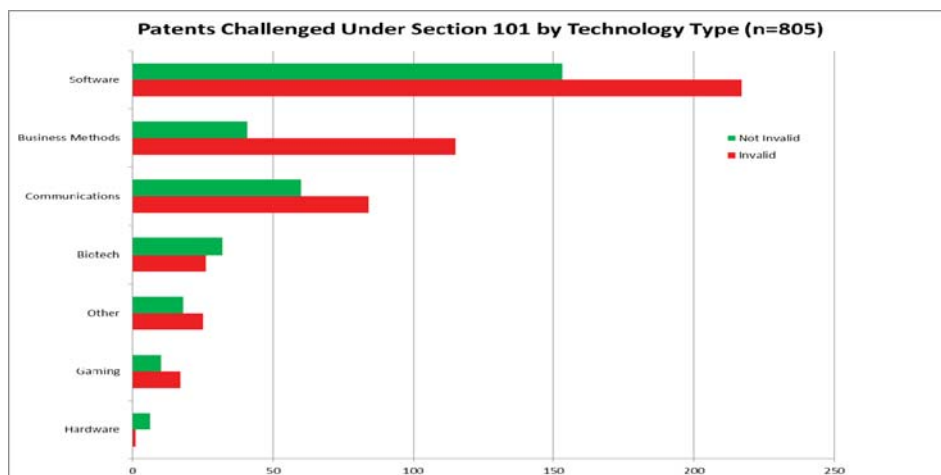
