- Member total – approximately 165,000
 - Supplemental Security Income (SSI)
 - Medically Dependent Children Program (MDCP)
 - Intellectual and Developmental Disability (IDD) waivers
 - Home and Community-based Services (HCS)
 - Texas Home Living (TxHmL)
 - Deaf Blind with Multiple Disabilities (DBMD)
 - Community Living Assistance and Support Services (CLASS)
 - Youth Empowerment Services (YES)

Service Coordination



TEXAS
Health and Human
Services

- Levels 1 to 3 determined by member need
 - Level 1 – greatest need (includes MDCP)
 - Level 2 – moderate need (includes personal care, nursing)
 - Level 3 – lowest need
- Named service coordinator
- Face-to-face and telephonic contact frequencies

STAR Kids Screening and Assessment (SK-SAI)



TEXAS
Health and Human
Services

- Goals for care
- Acute services, including behavioral health
- Long term services and supports (LTSS)
- School, work, and caregiver supports
- Medical Necessity and RUG (replaces MN/LOC)
Approved by Texas Medicaid Health Partnership (TMHP)
- Completed annually, at minimum

Required, identifies most needs, may trigger other modules
- Personal Care Assessment Module (PCAM)
- Nursing Care Assessment Module (NCAM)
- Medically Dependent Children Program Module (MDCP)
