FERC Regulation of Public Utilities



- FERC authority under FPA
 - Public utility electric transmission and sales for resale – FPA Sections 201, 205, 206.
 - FERC has exclusive jurisdiction over:
 - (1) the transmission of electric energy in interstate commerce,
 - (2) the sale of electric energy at wholesale in interstate commerce, and
 - (3) all facilities for such transmission and sale.
 - Corporate activities and transactions by public utilities – FPA Sections 203, 204, 305(b).
(e.g. mergers, issuances, interlocking directorates).
 - Accounting – FPA Section 301.
 - Reliability – FPA Section 215.

Federal Energy Regulatory Commissioners



- Five commissioners, no more than three from the same political party, appointed by the President, confirmed by the Senate; one is designated chairman.
- Five-year term, except that a commissioner appointed to fill a vacancy prior to expiration is appointed only for the unexpired term.

Federal Energy Regulatory Commissioners (cont.)



- **Commissioner Cheryl A. LaFleur** – Democrat, Massachusetts – began serving in 2010; confirmed for a second term in 2014; term expires June 30, 2019.
- **Nominee for Chairman – Kevin J. McIntyre** – Republican, Virginia – Co-leader of the Jones Day energy practice; represents clients in natural gas, conventional power, oil, hydropower and renewables.
- **Confirmed for Commissioner (currently designated Chairman) – Neil Chatterjee** – Republican, Kentucky – confirmed for the term expiring June 30, 2021; energy policy advisor to Senator Mitch McConnell of Kentucky; previously worked for the National Rural Electric Cooperative Association in Government Relations.
- **Confirmed for Commissioner – Robert F. Powelson** – Republican, Pennsylvania – confirmed for the term expiring June 30, 2020; Commissioner on the Pennsylvania Public Utility Commission since 2008; serves as President of the National Association of Regulatory Utility Commissioners (NARUC).
- **Nominee for Commissioner – Richard Glick** – Democrat, Virginia – for the remainder of a 5-year term expiring June 30, 2022; currently General Counsel for the Senate Energy and Natural Resources Committee; previously Vice President, Government Affairs for Iberdrola's renewable energy, electric and gas utility, and natural gas storage business in the U.S.

Key Electric Power Issues to be Addressed by New FERC Commissioners



Regional Transmission Organizations and Independent System Operators



- Organized markets are managed by regional oversight entities called Regional Transmission Organizations (RTOs) and Independent System Operators (ISOs), created in response to FERC's Orders 2000 and 888, to:
 - Facilitate competition among wholesale suppliers;
 - Provide non-discriminatory access to transmission by scheduling and monitoring the use of transmission;
 - Perform planning and operations of the grid to ensure reliability;
 - Manage the interconnection of new resources, e.g., generation, loads . . . ;
 - Oversee competitive energy markets to guard against market power and manipulation.
- Some are confined to a single state, while some cross multiple states.
 - In New England, Mid-Atlantic, and Midwest, regional RTO's create markets: ISO-NE, PJM, MISO, and SPP.
 - In New York and California, statewide RTOs run markets: NYISO, CAISO.
