Key Steps of an Effective Risk Assessment



- Risk:
 - Probability or threat of a negative occurrence
- Risk Causes:
 - Factors that could cause the risk event to occur or the absence of which will enhance likelihood of the risk event occurring
- Mitigating Controls:
 - Controls to ensure effective mitigation is in place for the risk causes

Example Risk	Risk Cause	Control
Car Accident	Lack of Sleep	Drinking Coffee
