PREVENTATIVE MEASURES AND  
POLICIES TO HAVE IN PLACE

## Emergency Operations Planning (EOP)

- ☐ Adopt a multi-hazard EOP in compliance with Texas Education Code Chapter 37
  - District employee training, disaster drills, measures to coordinate with law enforcement
  - Resources at Texas School Safety Center: <https://txssc.txstate.edu/>
- ☐ Create a school safety and security committee
  - Develop and implement emergency plans
  - Provide the district with campus, facility, or support services information
  - Conduct safety and security audit (required by law at least once every three years)
  - Conduct drills and training on mock scenarios

Tex. Educ. Code §§37.108; 37.109; Policy CK

## Policies to Adopt

---

- ☐ Categorize employees: Nonexempt, Exempt non-educators, and Exempt Educators
- ☐ Develop a policy on how to pay employees in the event of a disaster
- ☐ Develop an absence policy for staff and employees
- ☐ Create a written policy providing for the payment of labor costs to assist with FEMA reimbursement
- ☐ Consider development of Disaster Leave Bank policies

## Documentation to Have Handy and Secured

---

- ☐ Insurance Policies
  - Understand your insurance policies
  - Review insurance policies with disaster situations in mind
  - What coverage do you have/What coverage do you not have
- ☐ Receipts/Contracts
  - Reimbursements based on what you can prove you paid
