## Don't Check Your Ethics at the Door: The Ethical Implications of Legal Service Outsourcing<sup>1</sup>

### I. Introduction

The outsourcing of legal and law-related services, often termed “legal process outsourcing,”<sup>2</sup> has moved beyond the headlines<sup>3</sup> and into the mainstream.<sup>4</sup> The concept is not new; law firms and corporate law departments have been outsourcing legal work, such as document production and due diligence, in the United States for more than two decades.<sup>5</sup> More recently, though, there has been an explosion in overseas outsourcing (sometimes

called “offshoring”), particularly to India, but more recently, countries such as South Africa and the Philippines have become major players.<sup>6</sup>

Although the term “outsourcing” is often associated with sending work overseas, the term encompasses any situation in which an organization delegates a task to an external person or enterprise, usually to decrease costs or enhance quality. Such delegation by lawyers, to other lawyers and non-lawyer professionals or businesses, domestic or foreign service providers, has become a multi-billion-dollar global industry.<sup>7</sup>

The work outsourced includes services from administrative support, such as secretarial services and payment processing, to quasi-legal services such as transcription and document review, all the way up to high-level legal analysis.<sup>8</sup> A 2008 analysis of the ethics of legal outsourcing by the ABA Standing Committee on Ethics and Professional Responsibility (“ABA Committee”) cited several examples of outsourced tasks:

Outsourced tasks range from the use of a local photocopy shop for the reproduction of documents, to the retention of a document management company for the creation and maintenance of a database for complex litigation, to the use of a third-party vendor to provide and maintain a law firm’s computer system, to the hiring of a legal research service to prepare a 50-state survey of the law on an issue of importance to a client, or even to the engagement of a group of foreign lawyers to draft patent applications or develop legal strategies and prepare motion papers in U.S. litigation.<sup>9</sup>

Legal outsourcing implicates a range of ethical duties, but the fundamental guiding principle is neither complicated nor surprising: A lawyer who outsources work, whether it is to a lawyer or non-lawyer, in the United States or abroad, retains the ethical responsibilities she would have were she doing the work herself. If anything, outsourcing
