## Benefits of Arbitration

- Lower costs (?)
- Quicker
- Less stringent procedural rules
- More flexible deadlines

## Benefits of Arbitration cont'd

- Confidentiality (?)
- Arbitrators with employment law expertise
- Some control over arbitrator selection
- Easier access to the arbitrator

## Drawbacks of Arbitration

- Satellite/pre-arbitration litigation
- Arbitrator's fees
- Arbitration entity's fees
- More cases go to hearing

## Drawbacks of Arbitration cont'd

- Risk of compromise awards
- Nightmare arbitrator
- Too little procedure
- Limited appellate rights
