# State of Texas Policies

## *Intrastate Gas Transportation Curtailment Priority Requirements*

- TRRC Order No. 489
  - Issued November 30, 1972.
    - Prior to 1973 Arab oil embargo with rising oil prices.
    - Pipelines provided a fully bundled service.
  - Specified curtailment priorities in Texas in absence of a different filed and approved curtailment program.
    - Curtailments resulting from insufficient gas supply and/or pipeline capacity.
  - Predates FERC Order No. 636 (see Appendix).
- Applicability of Order 489:
  - Intrastate pipelines
  - Local distribution companies

# State of Texas Policies

## *Intrastate Gas Transportation Curtailment Priority Requirements*

- Curtailment priority:
  1. Human needs: residences, hospitals, schools, churches, etc.
  - 1-A. Agricultural uses, including irrigation and crop drying.
  2. Small industrial and commercial customers and to avoid serious damage to other industrial customers.
  3. Large users for fuel or raw material where alternate fuel cannot be used.
  4. Large users for boiler or other fuel where alternatives can be used.
  5. Interruptible customers.
- Electric generation priority?
