NonImmigrant Visa Policy Changes

New Policies to Know - Nonimmigrant

- October 1 – Incremental Implementation (I-485 and I-539) – USCIS 6/28/2018 Policy Memo on Notices to Appear and Checklists (AILA Doc. No. 18092634)
- August 28 – USCIS Extension of Suspension of Premium Processing for another 5 months at least until 2/19/19 (AILA Doc. No. 18092574) includes all H-1B I-129s filed with CSC or VSC except cap-exempt
- August 9 – Accrual of Unlawful Presence - USCIS Revised Policy Memo for F, J, and M Nonimmigrant Students (#18101938 AILA)

NonImmigrant Visa Trends

Trends to Know – Nonimmigrant

- USCIS Denying Change of Status Requests to F-1 students with more than 12 months of Curricular Practical Training 8 CFR § 214.2(f)(10)
- NOIRs issued on Approved H-1B petitions (#18101730 AILA) 8 CFR § 214.2(h)(11)(iii) Approval may have involved “gross error.” (33 days to respond – government must articulate proper basis for revocation. Standard for approval - preponderance of the evidence) Consider FDNS site visits and consular oversight – Visa Office Verification Unit.
