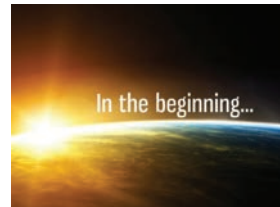

## ORIGINS OF RULE 91A



- House Bill 274, 2011:

The Texas Supreme Court shall adopt . . .

- “rules to promote the prompt, efficient and cost-effective resolution of civil actions”
- “rules to provide for the dismissal of causes of action that have no basis in law or fact on motion and without evidence”

TEX. GOV'T CODE § 22.004(g)-(h)

## TEX. CIV. PRAC. & REM. CODE § 30.021

- Along with these Government Code amendments, the 2011 Legislature also added CPRC Section 30.021
- **“In a civil proceeding, on a trial court’s granting or denial, in whole or in part, of a motion to dismiss . . . The court shall award costs and reasonable and necessary attorneys’ fees to the prevailing party.”**
- But: exceptions for government entity suits



## Tex. R. Civ. P. 91a Basics . . .

- Effective March 1, 2013
- Entitled:  
    **“Dismissal of Baseless Causes of Action”**
- At least 47 substantive opinions from Texas Courts of Appeals
- Family cases and inmate litigation excluded



## Tex. R. Civ. P. 91a Basics . . . continued

- Movant “submits to . . . jurisdiction only in proceedings on the motion”
- No waiver of personal jurisdiction
- “[D]oes not supersede or affect other procedures that authorize dismissal”
- Special exceptions and summary judgment motions unaffected – even on the same grounds

## It's not just a “little” version of Rule 12(b)(6)

“The Supreme Court Advisory Committee and its subcommittee went out of their way to make clear that the dismissal rule is not merely a little Rule 12(b)(6).”
