- Term “got off to a sleepy start,” but “potential blockbusters on the docket for the new year.” The Hill (Dec. 30, 2018)



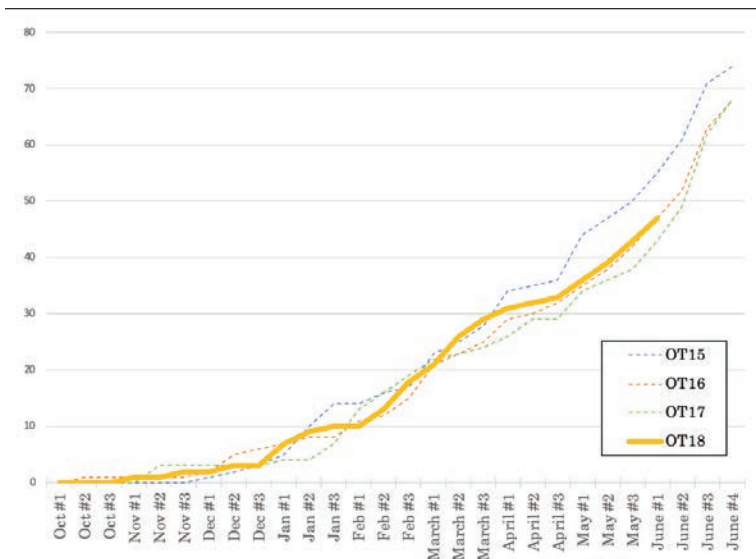
## STATISTICS TO DATE

- October Term 2017
    - 63 merits decisions in argued cases
    - Decisions divided 5-3 or 5-4: 19 (26%)
    - Unanimous: 28 cases
  - October Term 2018 (as of June 18)
    - 69 argued cases
    - 49 opinions issued in argued cases
    - Decisions divided 5-4 or 5-3: 12
    - Unanimous: 25
  - Number of 5-4 opinions (historical)
    - 2016: 7 (10%)
    - 2015: 4 (5%)
    - 2014: 19 (26%)
    - 2013: 10 (14%)
    - 2012: 23 (29%)

## JUSTICE BRETT KAVANAUGH – FIRST FULL TERM (AS OF JUNE 17)

- Six majority opinions to date
  - *Schein* (9-0); *Rimini* (9-0); *Quarles* (9-0); *Air & Liquid* (6-3); *Apple* (5-4); *Halleck* (5-4)
- Percentage voting agreement in full, part, or judgment (from Scotusblog, as of June 15): JGR (95%); SAA (91%); CT (81%); SGB (79%); EK (77%); NG (74%); RBG (72%); SS (72%).
- Dissents: *Cougar Den* (5-4)
- Notable vote alignments: *Apple v. Pepper*; *Moore v. Texas*; *Garza v. Idaho*; *Air & Liquid*
- By comparison:
  - NG OT'17: 7 majority opinions (one unanimous, one 7-2, five 5-4); 4 concurrences; 6 dissents
  - EK OT'10: 7 majority opinions (three unanimous, two 8-1, two 7-2); 0 concurrences, 3 dissents
  - SS OT'09: 8 majority opinions (four unanimous, one 8-1, two 7-2, one 6-3); 3 concurrences, 4 dissents
