Subrogation vs Reimbursement vs Assignment

Case law: “no meaningful difference between the two.” *Wausau v Wedel* TxSCt 06 08 2018. BUT:

BAM! Blue, Aldous and Malouf & \$114M jm for Hill.
Aldous v Darwin Nat’l Assurance Co 5th Cir, 03/16/17:

“Darwin, get off your Nat’l Ass and sue the third party, because your **subro interest vs 3rd party is not a right of reimb against your own insured.**”

Ch. 140 Civil Prac. & Rem. Code

For **insured** health, disability, occ injury; & self-funded state & local gov’t plans

Not w/c, not M/Care, not M/Caid

1/3 1/3 1/3 of 3rd party recovery

No subrogation to PIP
No subrogation to UM/UIM if ptf or family purchased it
No subro to children’s or w/d recoveries

PJC 15.5 includes elements of damages (e.g., loss of earning capacity and medical care expenses incurred before the age of majority) that reflect injuries to the minor, but that are not recoverable by the minor, the Committee felt that a revision was necessary
