- Dodd-Frank Wall Street Reform and Consumer Protection Act (Dodd-Frank Act), 12 U.S.C. §5301, et seq., was enacted in July 2010.
- The Dodd-Frank Act is a massive statute enacted in response to the financial crisis of 2008, which amended many different existing statutes, including the Commodity Exchange Act (CEA), the Bank Holding Company Act of 1956 (BHCA), and several other laws.
