- Need for engagement, connectedness and trust building as employers face handling varying circumstances of employees returning to work



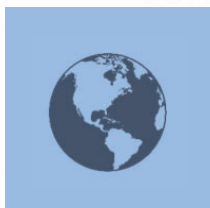

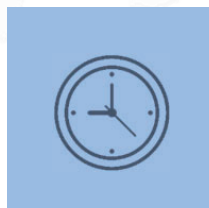

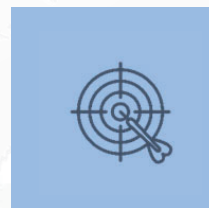
