## The Problem – The WOPR

---

- Over a decade ago brick and mortar commerce were still prevalent.
  - Brands and product creators would physically police stores.
    - Especially effective with major chains
    - A finite problem?
  - Path to market a product required overhead and infrastructure
  - Typically a highly centralized, supply chain dependent distribution system
  - Typically a single source for a knockoff/counterfeit
  
- Enter Online retailers
  - Distribution through online retailers
    - Amazon, eBay, Wish, Alibaba, etc.
  - Little overhead to start selling
  - Innumerable listings
    - Instant creation and propagation
    - A infinite problem?

---

- Amazon Brand Registry – Must
  - Registered trademark
  - Proprietary text and image search
  - Predictive automation based on your reports of suspected intellectual property rights violations
  - Increased authority over product listings with your brand name
- Select complaint category
  - Copyright
    - Registered
  - Trademark
    - Registration
  - Patent
    - Design
    - Utility – do you have a court order
  - Other
