18-0351 UNIVERSITY OF THE INCARNATE WORD v. VALERIE REDUS, ET AL.; from Bexar County; 4th Court of Appeals District (04-15-00120-CV, 580 SW3d 184, 03-07-18)
The Court affirms the court of appeals' judgment.

Justice Bland delivered the *opinion of the Court* , in which Justice Green, Justice Guzman, Justice Lehrmann, Justice Devine, Justice Blacklock, and Justice Busby joined.
