\*Denotes publications included in *Cheetah* (Wolters Kluwers), a searchable online compilation of *Trust Law Publications* and *Elder Law Publications* at [www.wkcheetah.com/](http://www.wkcheetah.com/) (costs about \$2,200 per year). This is the lowest-cost way of acquiring an online Elder and SNT Law library, very efficient if you write CLE papers or briefs or just want to be able to research the current law quickly. However, it must be supplemented, especially in the Medicaid field, with state-specific publications.

Abshire, Farrell, Sitchler & Wright, *Texas Elder Law*. Covers all Elder Law topics, with one chapter on Special Needs Trusts, applying law and policy effective in the state of Texas. Updated annually. Bush, Thomas E., *Social Security Disability Practice*. Very clear writing on complex, specialized topics. Essential to a law practice that includes disability determination and very useful for Special Needs Trust practice as well.

Choate, Natalie B., *Life and Death Planning for Retirement Benefits*. If you do any planning with tax-deferred retirement benefits, you must have this

book. It is both clear and comprehensive and is updated when the law changes. Available in hard copy or digital subscription at <https://ataxplan.com/life-and-death-planning-for-retirement-benefits/>

Courtney Richard A., *A Lawyer's Guide to Working with Special Needs Clients*. This is like having a conversation with a lawyer who loves his work and wants to encourage others who may have an interest in developing a Special Needs practice. He shares many personal experiences as well as discoveries and resources not usually found in a book on a legal specialty. It will be very helpful to attorneys considering moving to this field. Jeffreys, Jo-Anne Herina and Patricia E. Kefalas Dudek, *Representing the Elderly Client: Law and Practice*. Comprehensive Elder Law treatise with both forms and text but not state-specific\*

Johanson, Stanley, *Johanson's Texas Estates Code*. Virtually all Texas statutory law applicable to estate planning, probate and guardianship, with priceless annotations to the Texas Estates Code by Prof. Stanley Johanson. Thomson Reuters, in paperback and Proview (online), updated annually

Kruse, Clifton B., Jr., *Third-Party and Self-Created Trusts: Planning for the Elderly and Disabled Client*, Third Edition. Closing in on being 20 years old and mostly out of date, the Kruse treatise provides history and information not generally available from other sources; the book is often available at [www.amazon.com/](http://www.amazon.com/).
