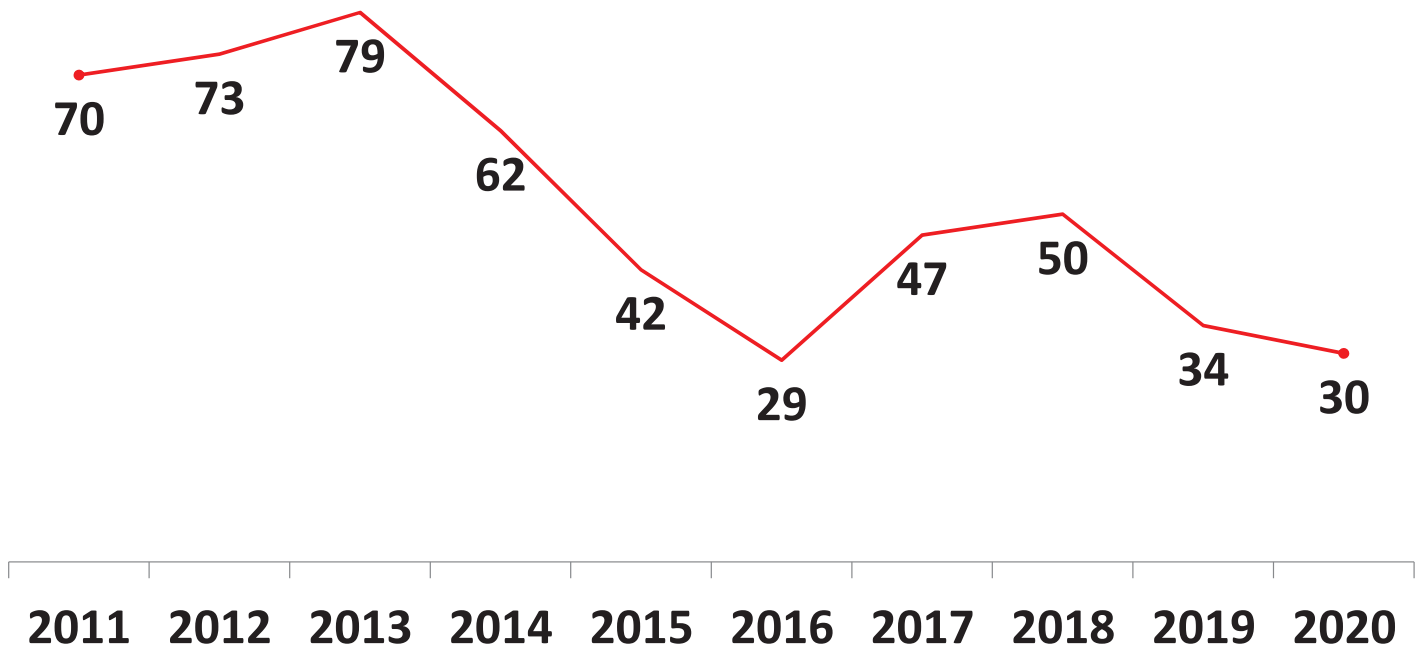

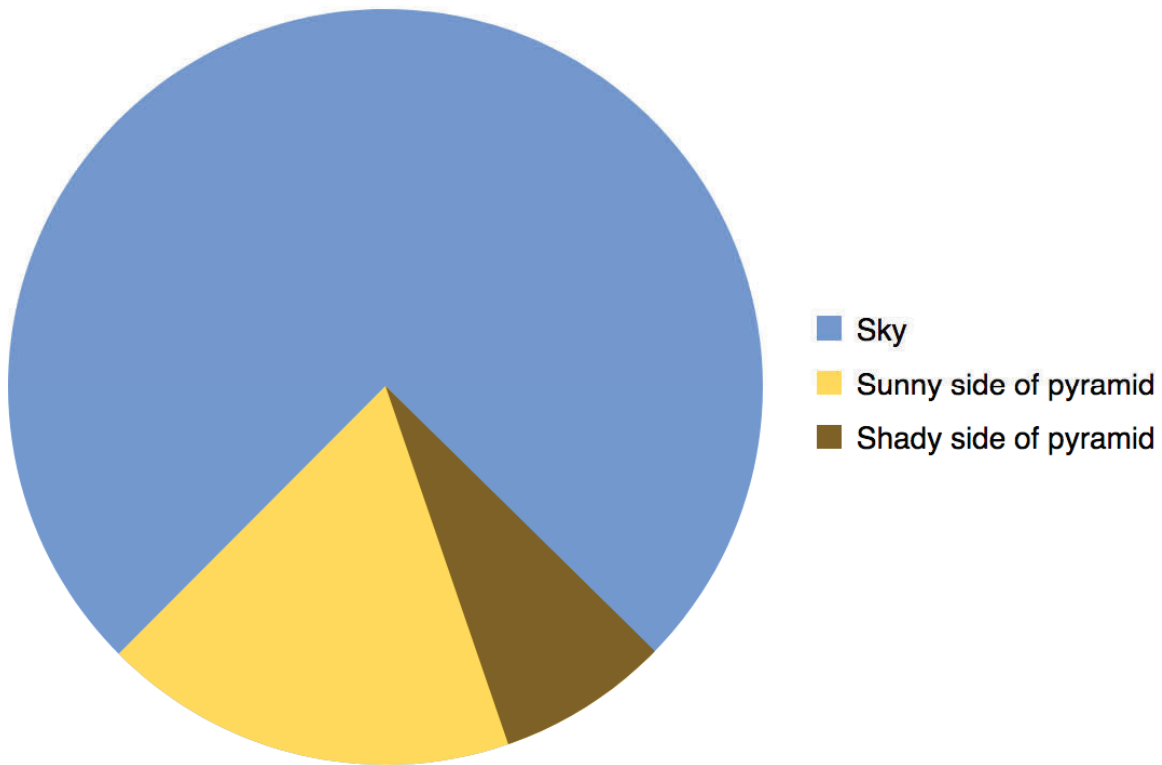

## Total Commissioner Decisions 2011-2020



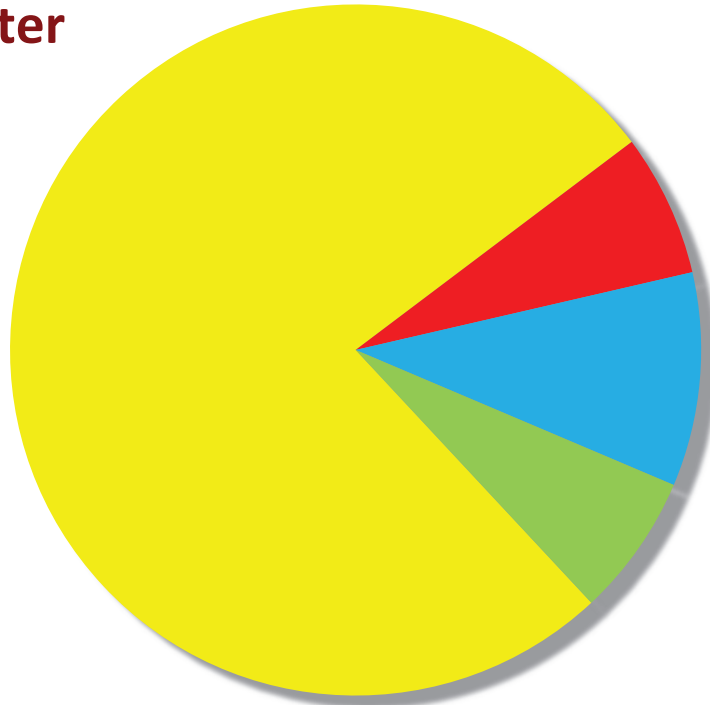
