What's the issue?

- Business leaders, legal professionals, and scholars have expressed deep concern about the impacts of the 2014 Supreme Court ruling in *Alice Corp. v CLS Bank Int'l*.
- Many believe the SCOTUS ruling significantly increased legal uncertainty surrounding the patentability of the key technologies that are part of the 4th Industrial Revolution, including those related to artificial intelligence.

Economic implications

- If true, increased legal uncertainty in patent rights can have significant and detrimental effects on economic outcomes including:
 - Lowering the expected value of patents
 - Decreasing ex-ante incentives to invest in innovation
 - Reducing transactions involving technologies (e.g. licensing)
 - Limiting entry into new markets

Alice Corp. v. CLS Bank Int'l

(referred to simply as *Alice* for convenience)

- The 2014 Supreme Court ruling had the following broad effects:
 - Extended the scope of the two-part test to patent eligibility for inventions potentially falling under the “abstract ideas” judicial exception (e.g. business method and software-related inventions)
 - Set a higher standard (or threshold) of patentability, meaning the Court in *Alice* clarified that a general purpose computer implementation alone was not enough
 - Created ambiguity without providing additional clarity

Why increased uncertainty?

- The source is:
 - The ambiguity of the language in the two-part rule for evaluating patentability.
- The words and phrases of the two-part rule can be reasonably interpreted in many ways, and the interpretive choice of any single person cannot be predicted with certainty.
 - This uncertainty is magnified as more and more people apply their viewpoints on the meaning of the words and phrases.
