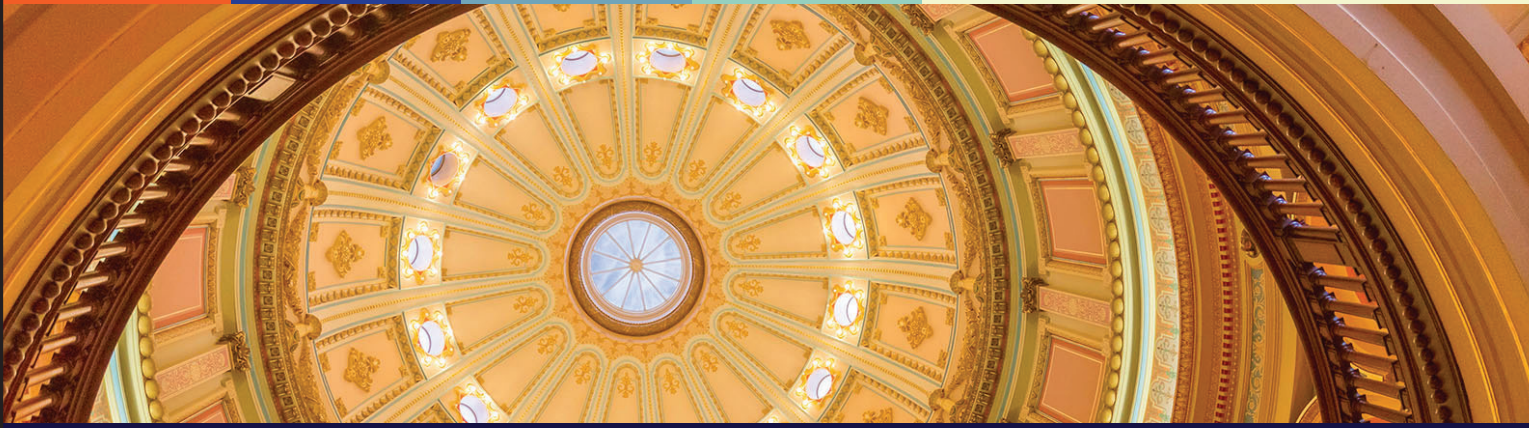

## State Privacy Laws

TYPE	SUMMARY
<b>Unfair and Deceptive Acts and Practices Laws</b> (State FTC-like laws)	<ul style="list-style-type: none"><li>• Gives State Attorneys General authority to prevent unfair or deceptive acts and practices</li></ul>
<b>Data Security Breach Notification Laws</b> (all states)	<ul style="list-style-type: none"><li>• Generally require entities that experience a data breach to provide notification to authorities and/or individuals</li></ul>
<b>Data Destruction/Disposal Laws</b> (Approx. 36 states)	<ul style="list-style-type: none"><li>• Generally require entities to destroy or dispose of personal information in a secure manner</li></ul>
<b>Data Security Laws</b> (Approx. 27 states)	<ul style="list-style-type: none"><li>• Generally require entities to use reasonable security standards to safeguard the personal information</li></ul>
<b>Biometric Privacy Laws</b> (Approx. nine states)	<ul style="list-style-type: none"><li>• Requirements regarding the collection, use, and sharing of biometric data from individuals</li></ul>
<b>“Comprehensive” Privacy Laws</b> (Two or four* states)	<ul style="list-style-type: none"><li>• See GDPR/CCPA/CDPA</li></ul>
<b>Data Broker Laws</b> (Two states)	<ul style="list-style-type: none"><li>• Requirements for “data brokers” regarding disclosure, consent and opt out</li></ul>

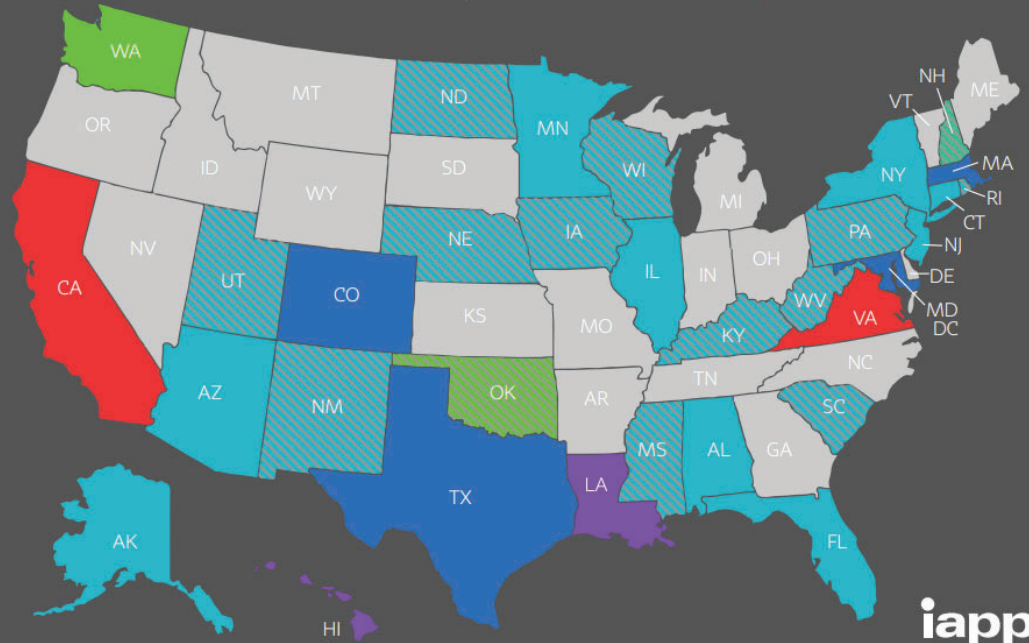
# State Comprehensive-Privacy Law Comparison
