# FAST FACTS

6,927 HOUSE & SENATE BILLS FILED; 1,073 (15.5%) PASSED BOTH HOUSES; 20 VETOED BY GOVERNOR

COMPARE TO 86<sup>TH</sup> R.S. - 7,324 BILLS; 1,429 (19.5%) PASSED; 56 VETOED BY GOVERNOR

LEGISLATIVE THEMES AFFECTING ADMINISTRATIVE LAW: DISASTER PREPARATION AND OPERATIONS, ELECTRIC & GAS RELIABILITY & OVERSIGHT, BROADBAND DEPLOYMENT, ACCESS TO INFORMATION, AND MORE

### 2021 SUNSET REVIEW

- •Evaluated 19 entities, including TDLR, TRS and Dept. of Agriculture.
- Legislature adopted 78% of recommendations through 12 bills.
- •115 statutory changes and 114 management directives:
  - •Increasing accountability
  - Streamlining licensing and services
  - Decreasing burdens on individuals

### 2021 SUNSET BILLS

- •Texas Animal Health Commission (TAHC) and Texas Department of Agriculture (TDA) -
  - •Addressed regulations and functions no longer needed or no longer cost effective.
  - SB 705: TAHC to close its disease testing laboratory and consolidates testing at Texas A&M.
  - SB 703: Eliminates aquaculture licensing program and two inactive entities. Improves fairness and performance of GO TEXAN marketing program and continues the Prescribed Burning Board Texas Boll Weevil Eradication Foundation.

## 2021 SUNSET BILLS, Cont'd

- Texas Department of Licensing and Regulation HB 1560
- Codes Affected: Alcoholic Beverage, Criminal Procedure, Education, Family, Government, Health & Safety, Human Resources, Occupations, and Transportation.
- ■TDLR to post additional statistical analysis of complaints.
- Requires risk- based inspections.
- TDLR to study Auctioneering
- Eliminates licensing for Polygraph Examiners.
- Consolidates licenses and certificates for both Barbers and Cosmetologists
- Repeals Residential Service Company Act, including licensing. Regulates through the Service Contract Regulatory Act.
- Postpones Sunset review of certain programs transferred to TDLR until 2032-33

# 2021 SUNSET BILLS, Cont'd

- Teachers Retirement System (TRS)-
  - ■HB 1585: improve outreach to members; establish ombudsman to investigate complaints and increase member input.
  - Sunset Commission Directives: related to contracting and to transparency of investment decisions
- •Next Up: Sunset Review for 21 entities, including PUC, ERCOT, Texas Juvenile Justice Department, and TCEQ
