## Notice and Cure Provisions

## Most requested change to loan documents:

- Monetary Defaults grace period after due date; additional time after written notice from lender; limited to certain number per year
- ▶ Non-Monetary Defaults some period to cudefault after written notice; time may be extended if can't be cured in specified time and borrower has commenced and is diligary pursuing cure
- Late Charge Specify that late charges do apply to failure to pay at maturity
