**Claim construction required before motion to dismiss for failure to state a claim.**

*Kirsch Research & Development LLC. v. Blueline Corp.*, Civil Action No. 6-20-cv-00326 (WD Tex. July 19, 2021), ([Defendant] “ask the Court to engage in pre-*Markman* claim construction and resolve that construction in its favor, this is premature.”(page 8)).
