Joint Operating Agreement

- **Joint Operating Agreements** (“JOAs”) used when a group of O&G working interest owners in one locality decide on mutual operations.
- Defines rights and obligations of co-tenants or divided interest owners of properties in a contract area.
- Effectively “pools” the interests of the working-interest owners.
- Helps avoid disputes between the JOA parties.

What Happens Without a JOA?

- Joint and several liability among partners
- A thicket of common actions—*e.g.* accounting
- Oral agreements that may or may not be valid
- Fact questions about mining partnership
- So, when do we see JOAs spring up?
 - Generally, when 2 or more parties are involved in operations over the same wells
- *Paper expands on JOA history & regional diffs.*

Joint Operations Without a JOA

State v. Harrington

407 S.W.2d 467 (1966)

- Oral agreement to drill a well among co-tenants
 - Texas Supreme Court found a mining partnership existed between defendants where they orally agreed to own a proportionate share of a well.
 - “All of the elements of a mining partnership—**joint ownership**, **joint operations**, **sharing of profits**, **community of interest** and **mutual agency** representing the mining partnership in management and operation—were proved without dispute...”
