- *Grimm v. Gloucester County School Board*, 972 F.3d 586 (4<sup>th</sup> Cir. 2020): Title IX and Equal-Protection Clause



- Right to privacy—Draft opinion in *Dobbs v. Jackson Women’s Health Organization*
  - Discrimination in Healthcare claims
    - Affordable Care Act: prohibits sex discrimination in the provision of healthcare by any health program or activity receiving federal financial assistance. 42 U.S.C. § 18116.
    - Lawsuits under Medicaid regarding coverage for treatment.
  - Religious exemptions from anti-discrimination laws
