



# Applicable Tax Exempt Organization (ATEO)

### What is an ATEO?

- An applicable tax-exempt organization ("ATEO") includes:
  - Organizations exempt from tax under section 501(a)
  - Exempt farmers' cooperatives (section 521(b)(1))
  - Political organizations (section 527(e)(1))
  - Organizations that have income excluded from gross income under section 115(1)

#### ATEO does <u>not</u> include:

- Some state universities
- Some state and local governments
- Certain foreign organizations
