# INDIVIDUAL ARTISTS & NONPROFITS

Pro bono legal and accounting services are offered to individual artists and arts related nonprofit organizations from all creative disciplines, including visual arts, musical performance, film and video, writing, acting, dancing, and performing arts. TALA facilitates 350-400 arts matches per year.

## PATENT PRO BONO

Through a partnership with the United States Patent and Trademark Office (USPTO), TALA's Patent Pro Bono program is designed to assist financially under-resourced independent inventors in Texas.

With the goal of advancing invention based economic development, the program matches patent attorneys and agents with inventors to assist in filing for patents with the USPTO.

## MEMBER QUALIFICATIONS



All individuals must be Texas residents with a household (HH) income below 300% of the federal poverty guidelines.

HH of 1 - under \$40,770

HH of 2 - under \$54,930

HH of 3 - under \$69,090

Artists can request assistance with issues directly related to their art practice.

Inventors must also:

- Complete a prior art search of their invention
- Complete the online USPTO Basic Patent Training Certification Course

Nonprofits and groups seeking 501c3 status must have an annual budget below \$200,000.
