- Duty to Act
- Take Reasonable Action (Rule 1.02 (g) TDRPC)
- Lawyers & Guardianship (In Re Thetford 62 Tex. Sup. Ct. J. 1126 (2019))
- Information Letter to Probate Court (TX Estates Code 1102.003)
- Report Abuse (Section 48.052 TX HR Code)

# Capacity in General

- Defined by the Texas Estates Code (1002.017 (2))
- Testamentary Capacity established in Bracewell v Bracewell (20 S.W.3d 14 (Houston [14<sup>th</sup> Dist.], 2000))

*Legal Capacity is the “ability to provide food, clothing and shelter for oneself; to care for one’s own physical health, and manage one’s own financial affairs.”*

*Texas Estates Code 1002.017(2)*
