## **2022 Election Cycle Overview**

- Republicans swept all statewide offices in Texas
- Republicans gained seats in the Texas Senate and House
- Texas gained 2 congressional districts this cycle
  - -CD 38 (Houston); and CD 37 (Austin/Central Texas)
- · Republicans gained ground in South Texas
  - -Including CD 15 Monica De La Cruz
- Democrats generally outperformed expectations nationally
- Republicans regained control of US House
- Democrats maintained control of US Senate
- Expect most ideologically conservative Texas legislature in history
- Expect significant congressional gridlock, particularly as the 2024 presidential election cycle looms

# 2022 Election Cycle Overview - State

- · Republicans maintained control of all statewide offices
  - Last Democrat elected statewide was in 1994
- Republicans gained one seat in the Texas Senate
  - -19/12 Republican majority
  - -With incremental weakening of the *traditional "2/3 rule,"* Republicans only need 18 votes to advance legislation
  - -6 new freshman senators
  - -Only one Democrat chairs a Senate committee
- Republicans gained three seats in the Texas House
  - –86/64 Republican majority
  - -25 new freshmen House members
  - Republicans hold majorities of all House committees
  - Democrats chair one-third of House committees

## 2022 Election Cycle Overview - Federal

- In considering historical mid-term, election cycle performance, Republicans generally underperformed, and Democrats outperformed expectations
- · Democrats retained control of the US Senate; picked up seats
  - 49 Republicans; 48 Democrats; 3 Independents (Sanders, King and Sinema, all of whom caucus with Democrats)
- Republicans took control of the US House
  - 222/213 Republican majority
  - House Speaker Kevin McCarthy
  - Democratic Majority Leader Hakeem Jeffries supplants Nancy Pelosi; signals the future of US House leadership
  - House Republican leadership has prioritized "cutting federal spending" and balancing the federal budget within 10 years
  - Anticipate considerable investment of House committees' time exploring COVID mandates and funding

### 2021-22 Interim Legislative Activity

- Several Texas Senate and House Standing Committees considered an array of health and human services issues during the legislative interim:
  - Use of American Rescue Plan Act (ARPA) funding: determining whether providers are complying with state reporting requirements, including reporting of COVID relief funds
  - COVID impacts on the health sector workforce, and mental health; and education deficiencies in Texas public schools
  - 1115 Medicaid Waiver and supplemental payment programs
  - Medicaid eligibility
  - Price transparency, competition, and consumer protections within the health insurance marketplace
  - Broadband infrastructure, telemedicine and telehealth
  - Interim Committee reports, and associated legislative proposals, emerged in the weeks before the beginning of the 2023 state legislative session
