---

- Specific, objective, and prescriptive guidance for staff and City Council to make decisions about petitions to create PIDs within the City or ETJ
- Issues to be addressed before the City or County can support the establishment and continuation of a PID as allowed by Ch. 372 of the Texas Loc. Gov't Code
- PID Policies and guidelines within the policies that promote the interests of the city or county and that confers a special benefit on a definable part of the city or county.

---

- What are the risk factors?
- What will the market allow for in terms of the assessments?
- How long will PID creation and other entitlements take?
- What is the cost of the land?
- What is the cost of public infrastructure?
- What costs cannot be paid by the PID?
- What are the costs of community benefits and PID fees?
- Is the project viable without a PID?
- Are all utilities available (both infrastructure and capacity)?
- What are the political considerations (when is the next election)?
