## Who Must Report?

#### 1.Domestic Reporting Companies –

 A corporation, limited liability company or any entity created by a filing with the secretary of state or similar office under the law of a state or tribal jurisdiction<sup>1</sup>

#### 2. Foreign Reporting Companies –

• A corporation, limited liability company, or other entity formed under the law of a foreign country that is registered to do business in any state or tribal jurisdiction by the filing of a document with a secretary of state or similar office<sup>2</sup>
