## Introduction

- Over the past year, Texas courts have issued decisions on a wide variety of topics in the gas and power space
- Many of these cases stem from the aftermath of Winter Storm Uri
- These cases implicate
  - The Public Utility Commission's (PUC) exclusive jurisdiction over party disputes with ERCOT
  - ERCOT's protection under sovereign immunity
  - PUC/ERCOT's ability to set non-competitive rates during emergency load-shedding events
  - The constitutionality of state rights of first refusal laws
  - Interpreting Force Majeure clauses in NAESB base contracts

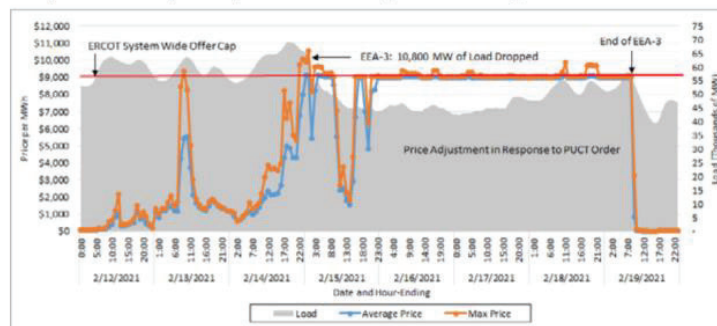

# Background: Winter Storm Uri and ERCOT

- Feb. 2021–Winter Storm Uri brought freezing temperatures and precipitation to Texas, which greatly stressed the ERCOT transmission grid
- Feb. 15th–ERCOT declared its highest state of emergency and directed transmission operators to shed load to maintain grid stability
  - PUC directed ERCOT to set electricity prices at the market cap of \$9,000/MWh
- Feb. 17th–ERCOT recalled load shedding, but kept high prices for 32 more hours
- Nearly half of all possible generation failed and energy companies had to spend billions to supply power to their users
- Hundreds of Texans died amid the blackouts, which lasted four days straight for some. Losses from the storm are estimated to be over \$100 billion
