Hospitals and Pharmacy Benefit Managers (PBMs) have been under increased scrutiny from policymakers in Austin and D.C.

- Other healthcare industries and policymakers on both sides of the aisles are targeting hospitals and PBMs for the perceived lack of transparency and the perceived role in increasing healthcare costs.

# Federal Legislation

- **Consolidated Appropriations Act – 2021 (CAA)**
  - Raising Fiduciary Bar for Health Plans
  - Plan Sponsor's to receive reporting on: i) 50 most frequently dispensed brand prescription drugs; cost prescriptions; greatest increase in expenditure, and ii) the ave. monthly premiums paid by participants, beneficiaries and enrollees and paid by employers.
  - Plans & Issuers to report the impact on premiums of rebates, fees, and any other remuneration paid by drug manufactures to plan or coverage or its administrators of serve providers.
  - ID brokers/consultants who are subject to CAA – i) require info on services/compensation, ii) new disclosure requirements and iii) formal process to determine is info is complete, relevant and reasonable in terms of total compensation.

## Federal Legislation – Continued

- **Prescription Drug Provisions in the Inflation Reduction Act (IRA) of 2022**
  - Federal government to negotiate prices
  - Requires pharma to pay rebates if prices rise faster than inflation
  - Cap out of pocket spending for Med-D enrollees at \$2,000
  - Limits annual increases in Part D Premiums for 2024-30
  - Limits monthly cost sharing for insulin products to \$35
  - Eliminates cost sharing for vaccines and improves access to vaccines

# Texas Pharmaceutical Initiative (TPI)

- Created by Texas Legislature in 2023 - \$150M
- Tasked to develop business plan to submit to 2025 Legislature to determine if they should establish:
  - Statewide PBM,
  - Distribution network for drugs and supplies,
  - Provide advanced pharmaceutical preparation services,
  - Conditions for Agency Participation, and
  - Identify cost savings and funding sources.

## PBM State Regulation Timeline

- 2020
  - US Supreme Court decided *Rutledge v. PCMA*
- 2021
  - 18 states enact PBM Laws; *PCMA v. Wehbi* decided (8<sup>th</sup> Cir.)
- 2022
  - 16 states enact PBM Laws; *PCMA v. Mulready* decided (W.D. OK)
- 2023
  - 24 states enact PBM laws; *PCMA v. Mulready* appeal (10<sup>th</sup> Cir.)
- 2024
  - US Supreme Court considers *PCMA v. Mulready* appeal
