## Recent Enforcement Initiatives

### Data Collection

- \$1.4 billion data privacy settlement, largest ever from a single state action.
- Ongoing enforcement actions against major technology platforms for illegally harvesting biometric data.
- Launched enforcement regime for consumer data breaches.
- MLB example of proactive outreach.

### Consumer Privacy

- Launched one of America's largest privacy enforcement teams.
- Began enforcing Texas's sweeping privacy law on Day 1.
- Groundbreaking suit against car manufacturer for harvesting drivers' data and selling it to insurance companies.
