U Visa Case Management: Timing

Why is it important?

- 80% of cases receive BFDs within 57 months (4 years and 9 months)
- Example

U Visa Case Management: Stages

Stages of a U Case:

- Obtaining certification
- U application filing
- · Waiting on BFD
- · BFD litigation
- · Waiting on the waitlist
- · Full U grant
- · Adjustment of Status or Consular Processing

U Visa Case Management: Setting Client Expectations

What's included in each stage?

- Change of address (how many)
- Case status updates how often and by whom
- EAD submissions or EAD renewals
- Criminal issues new waivers
- Divorce, new marriage

Best practices

- Include enough "wiggle room" in the contract to allow for unforeseen changes
- Set clear expectations with client and team
- Try to be proactive with updates clients want to make sure they're not forgotten
- Just because the government doesn't charge doesn't mean it's free labor for your clients
